1. The Trustees shall appoint an Honorary Secretary from amongst them and entrust to him the day to day work of the trust. He shall have power to appoint agent or employees for the proper maintenance of the trust properties
2. The Honorary Secretary will maintain property register containing up to date information about trust properties. He shall also maintain proper books of accounts
3. The annual accounts after proper check will be presented along with the annual report by the Honorary Secretary which the trustees shall consider at the annual meeting.
4. The meetings of the trustees shall be held as and when required and the Honorary Secretary shall issue due notice for the same.
5. If the trustees cannot conveniently meet the and decide upon certain matters necessary for the conduct of the trust business the same can be decided by circulating among the trustees and the majority decision obtained by such circulation shall have the same force as a resolution passed at a meeting of the trustees.
6. In matters where immediate decision is necessary with regard to trust properties or matters, the Honorary Secretary can obtain the orders of the Chairman and carry out the instructions and get the matters confirmed later either at a meeting or by circulation among the trustees.
7. All funds of the trust shall be deposited in the Bank and all money needed for expenditure shall be withdrawn by cheques by the Honorary Secretary who has already been authorised to operate the trust account.

This deed of Trust is declared at this day 8th day of October 1957 by me Shrimati Dewanini Vidyawati widow of the late Dewan Badri Nath of Jammu and Srinagar at present residing at Sheshwat Bawan, Srinagar.

Whereas I had been running a High School for Boys and a Middle School for Girls at Eminabad, District Gujranwalla founded by my noble father-in-law Dewan Amar Nath Sahib over forty years ago and I had founded an orphanage at Lahore to perpetuate the memory of my late husband Dewan Badri Nath Sahib in accordance with the last wishes of my late husband;

And whereas because of the ~~partik~~ partition of India the towns of Eminabad and Lahore are no longer in Bharat and the school building etc., are in the possession of the Government of Pakistan from whom so far no compensation has been received and it is no longer possible to run the school or the orphanage as Memorials to

the late Dewan Sahibs ;

And whereas the long connection of the line of my husband's illustrious family with the State of Jammu and Kashmir makes it incumbent upon me as a religious and pious duty to do all that is in my power to perpetuate the memory of my noble predecessors and for their spiritual well being and happiness dedicate a part of the property created by them and inherited by me from them to the service of the people whose welfare was always upper most in their minds ;

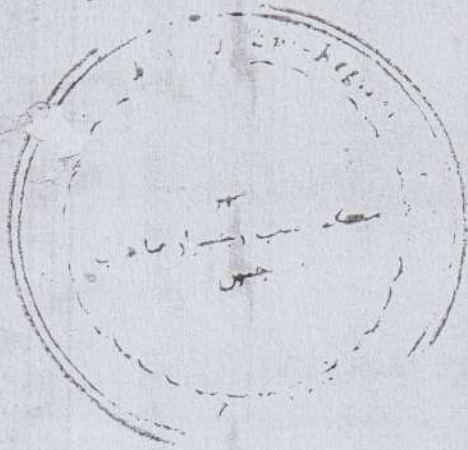

to whom these presents may come that I do hereby grant, dedicate and set apart absolutely free of all encumbrances all the properties and assets mentioned in schedule 1 hereto and I declare and appoint myself and the following persons :-

- 1) Shrimati Sushila Devi wife of Shri Narindrajit Singh ,
- 2) " Padma Devi wife of Shri B. K. Kapur,
- 3) Shri Narindrajit Singh , Bar - At - Law ,
- 4) Shri S. K. Chaku , Advocate ,
- 5) Shri P. N. Kapur, General Manager, Dewan Estates,

to be the Trustees for the management of the properties mentioned in schedule 1 for the purposes hereinafter mentioned and the manner hereinafter contained .

The said Trustees shall hold the properties movable and immovable in Trust and shall give effect to my intentions here-in-after laid down.

The aggregate market value of the properties described and detailed in the schedule hereto is of the value of not more than two and half lacs (Rs 2,50,000/- only) and the present nett annual income from the said properties which shall also vest in the aforesaid Trustees is about Rs 2500/- per annum or thereabout after deducting for annual vacancies, repairs etc.,. I hereby declare that the said properties and income thereof shall be used by the Trustees for the following purposes :-

- i) To provide free accomodation to a suitable Sanatanist High School for Boys in such of the buildings listed in the schedule 1 hereto as the Trustees deem proper to be named after my late husband Dewan Badri Nath Sahib.
- ii) To provide free accommodation to a Girl School in such of the building in schedule 1 as the Trustees deem fit and proper.

iii) To pay such amount as the Trustees consider necessary for Temple Trust already in existence and formally declared by me by deed dated 8th October 1957 for the maintenances of the Temples mentioned therein.

iv) To let out the remaining portions of the settled properties as the Trustees may consider proper and after defraying the necessary expenses of collection shall apply the balance to the up keep and maintenance of the dedicated properties and for meeting the other objects of the Trust mentioned herein above. Any balance remaining with the Trustees shall be utilized for creating a Reserve Fund which may be utilised for such Educational, Religious and Charitable objects as the Trustees may consider proper and specially for :-

- a) Founding and helping Educational Institutions ,
- b) Granting such stipends and scholarships to deserving students as the Trustees may deem fit ;
- c) Helping to found and support such childrens Home, Poor Homes and widows Homes as the Trustees may consider proper;
- D) Granting special donations to the Temple Trust already declared by me for the repair and renovation of Temple buildings.

- 1) The Trustees may associate themselves with such Educational and other institutions as mentioned above and may exercise such control over them as may be desirable.
- 2) The Trustees shall have power if they think fit to sell the properties vested in them . All moneys received by such sale shall form part of the Trust Fund and shall be applicable accordingly.
- 3) The Trustees may at any time or when they think expedient apply any part of the Trust fund in acquiring by purchase or on

lease or otherwise any land or building and any properties so acquired shall vest in the Trustees for the benefit of the Trust herein declared.

4) Subject as aforesaid the Trustees from time to time may make and alter rules and regulations with regard to the conduct of the business and all matters in respect of which any power or duty is hereby vested in them as they may think proper and in the absence of a unanimity amongst the Trustees all or any of the Trusts and Powers shall be capable of being performed or exercised by a majority of the Trustees hereof.

If the object for which this Trust has been created shall fail and cannot be fulfilled the Trustees shall be at liberty to apply the Trust fund and the property which is the subject of this Trust to any other object of alike nature which the Trustees shall consider proper.
